- 1. The No Objection Certificate now issued shall be subject to the terms and condition as prescribed in the G.O No.30720/SME dtd. 23.9.96 and No. 29519/SME dtd. 26.9.1998.
- 2. The land is to be recorded in the name of institution and copy of the record of rights to be furnished by the authority of the institutions within one year from the date of issue of the order.
- 3. Medium of instruction in the school shall be English but Oriya shall be taught as a subject to all pupils in the institution compulsory except the domiciles of other states and pupils of public servants on transfer from other states.
- 4. The school shall be open for inspection by the inspection committee.
- 5. No financial assistance and grant-in-aid (both recurring and non-recurring) will be claimed by the institution from the Govt. at any point of time for meeting the salary cost and its component towards teaching and Non-teaching staff appointed by the Managing Committee or for meeting any other expenses for managing the school.
- 6. The Managing Committee of the school will not shift the present location of the school without prior approval of the Director, Secondary Education, Odisha.
- 7. The Managing Committee shall be constituted in accordance with the section-7 of the Orissa Education Act-1969.
- 8. The NOC granted will be reviewed after three years and may be withdrawn if deficiencies pointed out are not complied under the column No-9.
